## **Helen D'Amato**

Helen D'Amato is a teacher by profession.

In 1993 she contested Local Council elections and was elected Vice Mayor of Zurrieq for a three-year period. In 1996 Ms D'Amato was elected for the first time as a Member of Parliament. Between 1998 and March 2004 she served as Chairperson of the Social Affairs Committee of the House of Representatives and also served as the Government representative on various boards and commissions. Ms. D'Amato was also a member of the Maltese delegation to the Parliamentary Assembly of the Council of Europe.

Between 2004 and 2008, Ms D'Amato served as Parliamentary Secretary responsible for the Elderly and Community Care. She is currently Senior Policy Advisor in the Ministry of Education, Culture, Youth and Sport.
