## **PRESS RELEASE**

### **CIVIL SOCIETY FUND 2008**

The Malta-EU Steering and Action Committee (MEUSAC) is calling for proposals from constituted bodies and representative organisations in order to assist such organisations to cover expenses actually incurred during 2008 in order to:

- keep abreast of developments in the European Union;
- enable them to better educate their members about EU matters related to their respective fields of competence; and
- enable them to participate effectively in the decision-making process at European level.

Since 1999, the Government has allocated more than €4.5 million to constituted bodies and representative organisations through the Fund.

The Civil Society Fund will cover expenses such as those related to participation in conferences, seminars and meetings abroad on matters directly related to the EU; expenses incurred in bringing over officials from the EU, or from institutions directly related therewith to discuss topics with an EU dimension of direct interest to their members and; attending familiarisation visits and specialised immersion programmes of the EU institutions and other bodies.

Organisations eligible for assistance under the CSF are the Social Partners and Voluntary Organisations (VOs), provided that they are established for the specific purpose of meeting needs in the general interest or in the interests of their membership and not having an industrial or commercial character. Supporting documents should be attached to the application form. Moreover, VOs which have enrolled with the Commissioner for Voluntary Organisations must attach the Certificate of Enrolment whilst those VOs which are still not enrolled must provide a copy of their application for enrolment and the acknowledgment received from the Commissioner for Voluntary Organisations.
