

## **CLIMATE CHANGE ON MEUSAC'S AGENDA**

The Core Group of the Malta-EU Steering and Action Committee (MEUSAC) met again on 24 April.

On the agenda was the European Commission's policy paper on how Europe can improve its resilience to climate change. The paper establishes a framework for action, focusing on:

- building a stronger knowledge base on the risks and impacts of climate change;
- taking account of climate change impact in key EU policies, in particular with regard to agriculture, fisheries, water resources, biodiversity protection, transport and energy;
- combining different policy measures;
- supporting wider international efforts on adaptation;
- working in partnership with national, regional and local authorities.

The White Paper was presented to Core Group members by MEPA official, Miraine Rizzo who explained the impact of climate change on Malta, focusing on an increase in flooding, coastal zones erosion and the deterioration in fresh water quality, as well as a negative impact on tourism due to the possibility of a rise in temperatures. Ms Rizzo said that Malta is vulnerable to climate change and thus, more data and information are required as well as a national strategy on adaptation to climate change.

Discussion among members focused on, amongst other matters:

- the need for more coordination for immediate actions for the adaptation to climate change, in particular with regard to the better usage of water and the re-use of treated water;
- higher sea water levels posing a threat to tourism; the negative impact of bad weather on the agriculture sector; higher temperatures threatening the biodiversity of marine ecosystems and consequently the fishing industry;
- whether studies are being conducted by the authorities concerned with regard to the monitoring of air quality and emissions;
- the need for small and medium sized enterprises to be better prepared for the transition to meet the goals of climate change adaptation;
- the collection of rain water;
- the sustainability of water use;
- the need for regulations from the concerned authorities for the housing sector.

### **PN appoints new member & substitute**

The Nationalist Party has replaced its representatives on the Core Group having nominated two members of parliament, Dr. Francis Zammit Dimech and Frederick Azzopardi as member and substitute member respectively. It was also decided that Ms Grace Attard and Ms Anna Borg would share the two-year term as civil society representative on the Core Group, as they both received an equal number of votes when the elections were held.

## IT-TIBDIL FIL-KLIMA FUQ L-AĠENDA TAL-MEUSAC

Il-*Core Group* tal-MEUSAC reġa' ltaqa' fl-24 ta' April.

Il-*Core Group* iddiskuta l-*White Paper* dwar l-adattament għat-tibdil fil-klima<sup>[1]</sup>, li permezz tagħha l-Kummissjoni Ewropea qed tistabbilixxi qafas għall-azzjoni billi tiffoka fuq:

- aċċess aħjar għal firxa aktar wiesgħa ta' *data* dwar l-impatt tal-klima;
- l-impatt tat-tibdil fil-klima fl-oqsma ewlenin tal-UE fosthom l-agrikoltura, is-sajd, l-ilma, il-ħarsien tal-bijodiversità, it-trasport u l-enerġija;
- azzjoni komuni bejn miżuri politiċi differenti għall-aqwa riżultati;
- appoġġ lejn sforzi internazzjonali aktar wiesgħa għall-adattament tat-tibdil fil-klima;
- ħidma fi sħubija mal-awtoritajiet nazzjonali, reġjonali u lokali.

Saret preżentazzjoni mis-Sinjorina Miraine Rizzo, uffiċjal tal-MEPA li tkellmet dwar l-impatt li t-tibdil fil-klima jista' jkollu fuq Malta. Fost dawn issemma' ċans ikbar ta' għargħar, l-erożjoni taż-żoni kostali, u d-deterjorazzjoni tal-kwalità tal-ilma feju. Hija qalet li minħabba t-tibdil fil-klima ċertu setturi jistgħu bħat-turizmu jistgħu jkunu affettwati f'hażin minħabba temperaturi ogħla. Malta hija vulnerabbli għat-tibdil fil-klima u għalhekk hemm bżonn ta' strateġija nazzjonali dwar l-adattament tat-tibdil fil-klima kif ukoll il-ġbir ta' iktar informazzjoni għall-għarfien aħjar dwar ir-riskji u l-impatti tat-tibdil fil-klima.

Il-Membri tal-*Core Group* qajmu diversi punti fost dawn:

- il-bżonn ta' iktar kordinazzjoni għal azzjoni immedjata għall-adattament tat-tibdil fil-klima, fost dawn l-użu aħjar tal-ilma u li jerga' jintuża l-ilma li jirriżulta mill-purifikazzjoni tad-drenaġġ;
- livelli ogħla tal-ilma tal-baħar huma ta' theddida għat-turizmu; iktar maltemp jista' jaffettwa b'mod negattiv il-biedja; waqt li temperaturi ogħla jeddu l-bijodiversità tal-baħar u għalhekk huwa ta' theddida għas-sajd;
- jekk hux qed isir studju mill-awtoritajiet konċernati dwar l-emissjonijiet f'pajjiżna u dwar il-kwalità tal-arja;
- il-bżonn li l-intrapriżi zgħar u ta' daqs medju jkunu ppreparati aħjar fit-tranzizzjoni biex jintlaħqu l-miri għall-adattament tat-tibdil fil-klima;
- ilqugħ għall-ilma tax-xita;
- is-sostenibbiltà fl-użu tal-ilma;
- il-ħtieġa li jkun hemm regoli mill-awtoritajiet konċernati għas-settur tal-bini.

Sar tibdil fir-rappreżentanti tal-Partit Nazzjonalista fuq il-*Core Group*, fejn ġew innominati l-Onor. Francis Zammit Dimech (Membru) u l-Onor. Frederick Azzopardi (Membru Sostitut). Ġie deċiż ukoll li bħala rappreżentanti tas-soċjetà ċivili fil-*Core Group*, is-sinjuri Grace Attard u Anna Borg jaqsmu t-terminu ta' sentejn, għal sena kull wieħed peress li kienu ġabu l-istess ammont ta' voti.
